## Unified Horse Show Development Program

### Application for Grant – Purpose, Eligibility & Criteria

#### **Purpose:**

The Unified Horse Show Development Program (UHDP), an initiative of the Foundation for the Advancement and Support of the Tennessee Walking Show Horse, Inc. (FAST), will award grants based upon the availability of funds and the ability of the grantee to present a funding application which meets the mission and purpose of FAST. Award grants will be for the primary purpose of building new shows/events, revitalizing dormant shows/events, or assisting struggling shows/events, that feature the Tennessee Walking Horse in all disciplines (flat shod and performance).

#### **Eligibility & Criteria:**

- 1. Show/event must be affiliated with a United States Dept. of Agriculture (USDA) recognized HIO in good standing.
- 2. Show/event shall be associated with a charity or beneficiary.
- 3. Show/event will submit their schedule, description, goals, and budget with grant application.
- 4. Show/event must have pledges of sponsorship of 25% or more of total budgeted income at time of application for grant.
- 5. Show/event shall submit their planned advertisement and promotional efforts with application for grant. Efforts must show a good faith effort in bringing new or potential exhibitors and shall reasonably publicize UHDP and FAST (promotional materials available).
- 6. Show/event must promote all disciplines of the Tennessee Walking Show Horse, but classes may be geared to one aspect of the breed.
- 7. Show/event must complete UHDP Evaluation and submit with final accounting to UHDP within fourteen (14) days after show/event
- 8. Show/event must submit their show/event results, if applicable, to TWHBEA, TWH media outlets, National and/or State Associations within seven (7) days following the show/event.
- 9. If the show/event is profitable, a donation to the UHDP to assist other shows/events is requested and appreciated.
